First Time Skilled Worker Visa

OVERVIEW

To move to the UK for work, you must be sponsored by a Home Office-approved employer to be coming to do a specific job in an eligible occupation. This visa allows you to live and work in the UK for up to 5 years before it needs to be extended. You can apply to bring your family with you as dependents.

DOCUMENTS REQUIRED

- Your passport.
- Your Certificate of Sponsorship reference number - your future employer should provide this.
- Bank statements.
- English language test certificate.
- Criminal record certificate, if required.
- A valid TB certificate, if required.
- Proof of your relationship with your partner or children, if they are applying as dependents.

REQUIREMENTS

- You meet the suitability requirements - good immigration history and acceptable criminal record.
- You must hold a valid Certificate of Sponsorship for your future job, issued by a Home Office-approved sponsor.
- You are applying no more than 3 months before the start date of your job.
- Your job is within an eligible skilled occupation.
- Your job meets the minimum salary requirements, which vary according to occupation and your qualifications.
- You have English language skills to a minimum of level B1.
- You have at least £1270 to cover your first month's expenses in the UK.

REASONS FOR REFUSAL

- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Insufficient or incorrect detail on Certificate of Sponsorship.
- Not understanding the financial requirements.
- Applying too early/late.

Skilled Worker Visa Extension

OVERVIEW

As a Skilled Worker, you can extend your visa as many times as you like as long as you still meet the requirements. While you will likely be eligible to apply for Indefinite Leave to Remain after 5 years, if your first visa was issued for a shorter period of time than this, you will need to extend it to ensure you continue to be legally resident in the UK.

DOCUMENTS REQUIRED

- Your passport.
- Evidence of current immigration status, e.g. BRP.
- Your updated Certificate of Sponsorship reference number.
- English language test certificate.
- Updated criminal record certificate, if applicable.
- Proof of your relationship with your partner or children, if they are applying as dependents.

REQUIREMENTS

- You continue to meet the suitability requirements - good immigration history and acceptable criminal record.
- You are still in the same job and with the same employer as when you were granted your previous work visa.
- You have a new Certificate of Sponsorship covering your extended period of employment.
- Your employer continues to hold a valid UK sponsorship license to employ Skilled Worker visa holders.
- You still receive an annual salary that meets the minimum salary requirements.
- You are applying no earlier than 60 days before the expiry of your current visa.

REASONS FOR REFUSAL

- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Not providing an updated Certificate of Sponsorship.
- Not meeting salary requirements.
- Employer losing sponsorship licence.
- Applying too early or too late.

Skilled Worker Indefinite Leave to Remain

OVERVIEW

Gaining Indefinite Leave to Remain (also known as Settlement) represents a big milestone in your immigration journey. You will be free from time restrictions on your residence in the UK and will no longer need to renew your visa. You will be able to access a wider range of public services, including the NHS for free. ILR is the final stepping stone to British citizenship.

DOCUMENTS REQUIRED

- Passport and any passports which expired during your UK residency.
- Evidence of current immigration status e.g. BRP.
- Pass certificate of Life in the UK test.
- Documents from your employer confirming your ongoing job & salary.
- Documents detailing any time spent outside the UK during your UK residency.
- A statement detailing your immigration history.
- Financial information, including bank statements.

REQUIREMENTS

- You continue to meet the suitability requirements - good immigration history and acceptable criminal record.
- You have been lawfully resident in the UK for a specified period of time. Usually this is 5 years, but it may vary.
- You must continue to be needed for the job you have been sponsored for previously and continue to meet the salary requirements.
- You have not spent more than 180 days outside the UK within any year of your qualifying period.
- You have passed the Life in the UK test.
- You are not applying too early. The earliest you can apply is 28 days before you have been in the UK for 5 years.

REASONS FOR REFUSAL

- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Not providing evidence of ongoing employment.
- Too much time outside UK in qualifying period.
- Not passing the Life in the UK test.
