Fiancé(e) Visa

OVERVIEW

If you are engaged to a British citizen or a person who is a settled UK resident, you can apply for a visa to come to the UK to get married. A fiancé(e) visa is usually issued for 6 months. After your wedding, you can then switch to a spouse visa to carry on living in the UK.

DOCUMENTS REQUIRED

- Yours & fiancé(e)'s passports.
- Statement with documents to prove relationship is genuine.
- Evidence of wedding plans.
- Any divorce certificates.
- Confirmation of fiancé(e)'s income/savings.
- Mortgage deeds/tenancy agreement.
- English language test certificate.
- & more depending on your circumstances.

REQUIREMENTS

- You meet the suitability requirements - good immigration history and acceptable criminal record.
- Your fiancé(e) is British or present and settled in the UK.
- You and your fiancé(e) have met in person, are in a genuine relationship, and are intending to marry in the UK.
- Your fiancé(e) earns at least £18,600 per year, or you have at least £62.5k in savings.
- You will be living in suitable accommodation, without needing public financial support.
- English Language skills to a minimum of level A1.

REASONS FOR REFUSAL

- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Not providing enough evidence of your wedding plans.
- Not understanding how to meet financial requirements.
- Not passing the correct English language test.

First Time Spouse & Partner Visa

OVERVIEW

As the husband/wife or long-term partner of a British citizen or settled resident, you can apply for a visa to live in the UK. Successful applicants can initially stay for 2.5 years and extend it for another 2.5 years, leading to the possibility of ILR and British citizenship.

DOCUMENTS REQUIRED

- Your passport & spouse/partner's passport.
- Marriage certificate.
- Statement with documents to prove relationship is genuine.
- Confirmation of partner's income/savings.
- Mortgage deeds/tenancy agreement.
- English language test certificate.
- & more depending on your circumstances.

REQUIREMENTS

- You meet the suitability requirements - good immigration history and acceptable criminal record.
- Your spouse/partner is British or present and settled in the UK.
- You are married or have lived with your partner for at least 2 years.
- Your relationship is genuine and you intend to live with your spouse/partner in the UK.
- Your spouse/partner earns at least £18,600 per year, or you have at least £62.5k in savings.
- You will be living in suitable accommodation, without needing public financial support.
- English Language skills to level A1.

REASONS FOR REFUSAL

- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Not providing enough evidence of your relationship.
- Not understanding how to meet financial requirements.
- Not passing the correct English language test.

Spouse & Partner Visa Extension

OVERVIEW

After 2.5 years living in the UK with your British or settled spouse or partner, you will need to extend your visa for a further 2.5 years. It is important to do this to make sure you are still legally allowed to live in the UK. After successfully completing this extension period, you will likely be eligible to apply for settlement.

DOCUMENTS REQUIRED

- Your passport & spouse/partner's passport.
- Marriage certificate.
- Statement with documents to prove relationship is genuine.
- Confirmation of your income/savings.
- Mortgage deeds/tenancy agreement.
- English language test certificate.
- & more depending on your circumstances.

REQUIREMENTS

- You continue to meet the suitability requirements - good immigration history and acceptable criminal record.
- Your spouse/partner is British or present and settled in the UK.
- You and your spouse/partner have lived together since you first arrived in the UK.
- You can provide proof that your relationship is genuine.
- Between you and your partner, you earn at least £18,600 per year, or you have at least £62.5k in savings.
- You will be living in suitable accommodation, without needing public financial support.
- English Language skills to level A2.

REASONS FOR REFUSAL

- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Not providing enough evidence of cohabitation.
- Not understanding how to meet financial requirements.
- Not passing the correct English language test.

Spouse & Partner Indefinite Leave to Remain

OVERVIEW

Gaining Indefinite Leave to Remain (also known as Settlement) represents a big milestone for you and your family. You will be free from time restrictions on your residence in the UK and will no longer need to renew your visa. You will be able to access a wider range of public services, including the NHS for free. ILR is the final stepping stone to British citizenship.

DOCUMENTS REQUIRED

- Passport and any passports which expired during your UK residency.
- Pass certificate of Life in the UK test.
- Pass certificate of English language test.
- Birth, adoption and marriage certificates.
- Documents detailing any time spent outside the UK during your UK residency.
- A statement detailing your immigration history.
- Financial information, including bank statements.
- & more depending on your circumstances.

REQUIREMENTS

- You continue to meet the suitability requirements - good immigration history and acceptable criminal record.
- You have been lawfully resident in the UK for a specified period of time. Usually this is 5 years, but it will depend on the type of visa you have held.
- You must still be in a genuine relationship with your spouse/partner & intend to continue living together.
- You have not spent more than 180 days outside the UK within any year of your qualifying period.
- Combined income of at least £18,600.
- You have English language skills to a minimum of level B1.
- You have passed the Life in the UK test.

REASONS FOR REFUSAL

- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Not providing enough evidence of cohabitation.
- Too much time outside UK in qualifying period.
- Not passing the Life in the UK/Language tests.
