# First Time UK Ancestry Visa

### **OVERVIEW**

The UK ancestry visa is a programme that allows Commonwealth citizens with a grandparent who was born in Britain to live, work and study in the UK. This visa is usually granted for a period of 5 years, after which you are likely to be eligible to apply for settlement. You can apply to bring your family with you.

### **DOCUMENTS REQUIRED**

- Your passport
- · Your full birth certificate
- The full birth certificates of the parent and grandparent your ancestry claim is based on, plus evidence of any name changes
- Bank statements to show you can support yourself
- Evidence of your intention to work in the UK, e.g.
   CV/business plan
- A valid TB certificate, if required

### **REQUIREMENTS**

- You meet the suitability requirements - good immigration history and acceptable criminal record.
- You must be a Commonwealth citizen.
- You must have a grandparent who was born in the UK, the Channel Islands or the Isle of Man
- You must be able to cover the costs of your accommodation and day-to-day living expenses without replying on government assistance, You can be supported by a family member or friend, but they need to provide assurance that this is a legitimate offer.
- You must be able to work, and intend to find a job or pursue self-employment in the UK.

### **REASONS FOR REFUSAL**

- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Not providing enough evidence of your ancestry claim.
- Not providing evidence of intention to work in the UK.

## **UK Ancestry Visa Extension**

### **OVERVIEW**

You can extend your UK
Ancestry visa as many times as
you like, as long as you
continue to meet the
requirements. While many
visa-holders will be able to
apply for Indefinite Leave to
Remain after their first 5 years
in the UK, extending your UK
Ancestry visa may be
necessary if your stay in the UK
has not been continuous
during the first period of your
visa.

### **DOCUMENTS REQUIRED**

- Your passport
- Evidence of current immigration status, e.g. BRP.
- Evidence of your employment or selfemployment in the UK
- Confirmation of income/savings.
- Mortgage deeds/tenancy agreement.
- & more depending on your individual ciricumstances.

### REQUIREMENTS

- You continue meet the suitability requirements good immigration history and acceptable criminal record.
- You must already hold a UK Ancestry visa which has not yet expired.
- You are still a Commonwealth citizen.
- You have secured employment in the UK, either through an employed role or self-employment, or that you are actively seeking work
- You can continue to support yourself and any dependents in the UK financially and will be living in suitable accommodation without needing public financial assistance.

### **REASONS FOR REFUSAL**

- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Not evidencing financial stability.
- Not evidencing employment/selfemployment or that you are actively seeking work if you are currently unemployed.

# UK Ancestry Indefinite Leave to Remain

### **OVERVIEW**

Gaining Indefinite Leave to Remain (also know as Settlement) represents a big milestone for you and your family. You will be free from time restrictions on your residence in the UK and will no longer need to renew your visa. You will be able to access a wider range of public services, including the NHS for free. ILR is the final stepping stone to British citizenship.

### **DOCUMENTS REQUIRED**

- Passport and any passports which expired during your UK residency.
- Pass certificate of Life in the UK test.
- Birth, adoption and marriage certificates.
- Documents detailing any time spent outside the UK during your UK residency.
- A statement detailing your immigration history.
- Financial information, including bank statements.
- & more depending on your circumstances.

### **REQUIREMENTS**


- You continue to meet the suitability requirements good immigration history and acceptable criminal record.
- You have been lawfully resident in the UK for 5 years on an Ancestry visa.
- You are still a Commonwealth citizen.
- You have not spent more than 180 days outside the UK within any year of your qualifying period.
- You can adequately support and maintain yourself.
- Depending on your nationality, you may need to meet certain English language requirements.
- You have passed the Life in the UK test.
- You are not applying more than 28 days before the expiry of your current visa.


### **REASONS FOR REFUSAL**


- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Too much time outside UK in qualifying period.
- Applying too early.
- Not passing the Life in the UK/Language tests.
