# British Citizenship Application

## OVERVIEW

The process of becoming a British citizen is known as 'naturalisation'. As a naturalised British citizen, you will be eligible for a UK passport and have the same rights and privileges as a British person. You will be able to live, work, vote and access public funds in the UK. You will also be free of immigration control, which means you can travel into and out of the UK freely for the rest of your life.

## DOCUMENTS REQUIRED

- Proof of identity, e.g. passport, birth certificate.
- Proof of your current immigration status, e.g. your BRP.
- Relevant birth, adoption & marriage certificates.
- Information related to any absences from the UK.
- Life in the UK test certificate
- English language test certificate
- & more depending on your circumstances

## REQUIREMENTS

- Have held ILR/EU Settled status for at least 12 months. This is not necessary if you are married to a British citizen.
- Were physically present in the UK exactly 5 years before the date of your application. This would be 3 years if applying via the marriage route.
- Have spent at least 5 years of continuous residence in the UK, with no longer than 450 days outside the UK (270 for marriage route).
- Not have been absent for the UK for 90 days or more in the last 12 months.
- Good immigration history.
- Have passed Life in the UK test.
- English language skills to at least B1 level.
- Intend to make the UK your permanent home.
- Meet the 'good character' requirement, in relation to your criminal history, immigration history and financial status.
- You will need to provide two references.
- You will need to attend a Citizenship Ceremony, where you take an oath and make a pledge.
- Pay fee of £1330 to the Home Office.



# British Citizenship for Children Application

## OVERVIEW

Registering a child as a British Citizen is a crucial step for parents who want to secure their child's legal status in the United Kingdom. There are many benefits to becoming a British Citizen for your child in both the short-term and the long-term. ## REQUIREMENTS

The requirements for registering your child as a British Citizen vary according to your family's specific circumstances. Your child's age is also a factor.

We regularly assist families in cases where one or both parents have been granted ILR or Citizenship after the birth of their children and who now want their children to have the same status.

We can also support families to gain British Citizenship where a child has lived in the UK for the first 10 years of their life, irrespective of whether the parents have acquired permanent residence.

If your child was born abroad and you have 'Citizenship by descent', we can support you in registering them for British Citizenship.
