Student Visa

OVERVIEW

International students with an offer to study at a recognised British educational institution are eligible to apply for a student visa. Student visas are normally granted for the duration of your course and you will usually be able to work part-time in the UK alongside your studies.

DOCUMENTS REQUIRED

- Your passport.
- A Confirmation of Acceptance for Studies from your university/college.
- Certificates of your current qualifications.
- Bank statements/other evidence of how you are financing your studies.
- English language test certificate.
- An ATAS certificate, if your course and nationality require.
- A valid TB certificate, if required.

REQUIREMENTS

- You meet the suitability requirements - good immigration history and acceptable criminal record.
- You have been issued with a valid Confirmation of Studies (CAS) by a Home Office approved university/college.
- You are applying no more than 6 months before the start date of your course.
- You will be studying on a course which meets Home Office specifications.
- You have enough money in your bank account to pay your course fees and at least £1023 per month for living expenses, for a period of 9 months. You will need more funds if based in London.
- You have English language skills to a minimum of level B2.

REASONS FOR REFUSAL

- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Not evidencing that you are a 'genuine' student.
- Insufficient or incorrect detail on Confirmation of Studies.
- Applying too early/late.

Graduate Visa

OVERVIEW

The Graduate visa is designed to attract international students who have completed their higher education in the UK and wish to remain in the country to gain valuable work experience. This visa is usually issued for 2 years, and you do not need a job offer before you apply.

DOCUMENTS REQUIRED

- Your passport.
- Your BRP/evidence of your UK immigration status. You need to hold a Student/Tier 4 (Student) with valid leave remaining to apply for this visa.
- Your Confirmation of Acceptance for Studies from your university/college, from when you previously applied for your Student Visa.
- Proof of your relationship to your dependents, if you are applying with them.

REQUIREMENTS

- You meet the suitability requirements - good immigration history and an acceptable criminal record.
- You're in the UK at the time of applying for your visa.
- Your current visa is a Student visa or Tier 4 (General) student visa with valid leave.
- You studied a UK bachelor's degree, postgraduate degree or other eligible course for a minimum period of time with your Student visa or Tier 4 (General) student visa.
- Your education provider (such as your university or college) has told the Home Office you've successfully completed your course.

REASONS FOR REFUSAL

- Incorrectly completed application form.
- Misunderstanding Home Office guidance.
- Not evidencing that you have been in the UK on a valid Student visa.
- Your university or college not confirming to the Home Office that you have successfully completed your course.
